

PRIVACY POLICY

Truckerbux, LLC (hereinafter, “Truckerbux”, “Company”, “Us”, “Our”, or “We”) recognize that you may be concerned about our collection, use, and disclosure of your personal information. We respect your privacy and are committed to providing a transparent notice of our privacy practices.

This policy describes the types of information We may collect from you when you visit our website, including <https://www.truckerbux.com/> (our "Website") or through our mobile application (“App”). This policy also covers information We collect about you offline, from third parties, or when contact us by phone. This policy describes our practices for collecting, using, maintaining, protecting, and disclosing that information.

Our Website and App is designed for use by business customers and prospects, such as a trucking business owners/operators, carriers, or commercial truck repair and mechanics. We do not purposefully collect information on individual consumers or individuals outside of their capacity as employees of a business partner or business prospect or as a potential job applicant with our company.

Truckerbux facilitates repairs and payment between truckers and repair shops (“Services”) through our App. Please note that our Services are currently only available in the state of Alabama.

Please read this policy carefully to understand our policies and practices regarding your information and how We will treat it. This policy may change from time to time (see Changes to Our Privacy Policy).

INFORMATION COLLECTION

We collect several types of information from and about you, including:

- **Information provided by you**, such as name, address, email address, telephone number, and other personally identifying information. For example, We collect information from you when you download our App, request a repair service, submit a quote as a repair shop or mechanic vendor, or make a payment;
- **Information provided by third parties** about you. As part of our Services, We may also collect information from third parties, such as payment processors; and

- **Information collected automatically** as you navigate through the Website or use the App. Information collected automatically may include usage details, domain address, IP addresses, internet browser, operating system, your internet connection, the equipment you use to access our Website, geolocation data through your use of the App, and information collected through cookies.

INFORMATION USE

We use information that We collect about you or that you provide to us:

- to present our Website and App and its contents to you and to improve our Website and App (We continually strive to improve our Website and App offerings based on the information and feedback We receive from you);
- to provide you with information or services that you request from us;
- to fulfill Our obligations to you as a commercial customer or vendor;
- to provide you with notices about your account and to improve customer service (your information helps us to more effectively respond to your customer service requests and support needs);
- to carry out Our obligations and enforce our rights arising from any contracts entered into between you and Us, including for billing and collection;
- to notify you about changes to our Website or App or any products or services We offer or provide through either;
- to allow you to participate in interactive features on our Website and through our App and to personalize your experience (your information helps us to better respond to your individual needs);
- to enable communications to you regarding our services such as email and text;
- to work with marketing partners to provide you with products or services that may be of interest to you;
- to fulfill any other purpose for which you provide it and in any other way We may describe when you provide the information; and
- for any other purpose with your consent.

DISCLOSURE OF YOUR INFORMATION

We may disclose information that We collect about you or that you provide us directly as described in this privacy policy:

- to our subsidiaries and affiliates;
- to contractors, service providers, and other third parties We use to support our business;
- to a buyer or other successor in the event of a merger, divestiture, restructuring, reorganization, dissolution, or other sale or transfer of some or all of Company's assets, whether as a going concern or as part of bankruptcy, liquidation, or similar proceeding, in which personal information held by Company about our Website or App users is among the assets transferred;
- to fulfill the purpose for which you provide it. For example, to process your inquiry regarding our services, to process your payment, to locate you during a roadside break-down, and related Services;
- for any other purpose disclosed by us when you provide the information;
- with your consent.

We may also disclose your personal information:

- to comply with any court order, law, or legal process, including to respond to any government, regulatory, or law enforcement request;
- to enforce or apply our Terms and Conditions and other agreements, including for billing and collection purposes; and
- if We believe disclosure is necessary or appropriate to protect the rights, property, or safety of Company, our customers, or others. This includes exchanging information with other companies and organizations for the purposes of fraud protection and credit risk reduction.

We may disclose aggregated information about our users and deidentified data or information that does not identify an individual.

SECURITY

We have implemented reasonable measures designed to secure your personal information from accidental loss and from unauthorized access, use, alteration, and disclosure. The safety and security of your information also depends on you. Where We have given you (or where you have chosen) a password for access to our App and certain parts of our Website, you are responsible for keeping this password confidential. We ask you not to share your password with anyone.

LINKS

This Website or App may contain links to other sites. Please be aware that We are not responsible for the content or privacy practices of such other sites. We encourage our users to be aware when they leave our site and to read the privacy statements of any other site that collects personally identifiable information.

CHILDREN UNDER THE AGE OF 13

Neither our Website, nor our App, is intended for children under 13 years of age. No one under age 13 may provide any information to or on the Website. We do not knowingly collect personal information from children under 13. If you are under 13, do not use or provide any information to or on this Website or through any of its features. If We learn We have collected or received personal information from a child under 13 without verification of parental consent, We will delete that information.
